1. *Laligurans Municipality, Office of Municipal Executive, Basantapur, Tehrathum* has allocated funds or received a grant from *The Embassy of India, Kathmandu* towards the cost of *The Construction of Cold Store at Laligurans Municipality, Ward No. 2, Tehrathum District, Koshi Province, under HICDP* and intends to apply part of the funds to cover eligible payments under the Contract for CIN: LM/NCB/W/09/2082-83. Bidding is open to all eligible as per Section V of bidding document.
2. *Laligurans Municipality, Office of Municipal Executive, Basantapur, Tehrathum* invites electronic bids from eligible bidders for the construction of *The Construction of Cold Store at Laligurans Municipality, Ward No. 2, Tehrathum District, Koshi Province, under HICDP* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: *[NRs. 56,000,000.00]*
 - Minimum Work experience of similar size and nature: *At least One (1) Building Contract with a value of at least [NRs 18,700,000.00]*
3. Under the Single Stage, Two Envelope Procedure, Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of *Laligurans Municipality, Office of Municipal Executive, Basantapur, Tehrathum* or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 5. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document upon payment of a non-refundable fee of NRs. 5,000.00 till 2083/02/27 (June 10, 2026) in the account as specified below.

6. Pre-bid meeting shall be held at *Laligurans Municipality, Office of Municipal Executive, Basantapur, Tehrathum* on 2083/02/18 (June 01, 2026) at 14.00 hrs.
7. Electronic bids must be submitted to the office *Laligurans Municipality, Office of Municipal Executive, Basantapur, Tehrathum* through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12.00 on 2083/02/27 (June 10, 2026). Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13.00 on 2083/02/27 (June 10, 2026). at the office of *Laligurans Municipality, Office of Municipal Executive, Basantapur, Tehrathum*. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of [NRs. 14,00,000.00], which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
